Student Complaint Procedures Update

The "Student Complaint Procedures" section of the 2006-2009 Bulletin (page 38) has been revised to clarify the process for Ph.D. students in Engineering. It now reads as follows:

"From time to time, students may feel that they have legitimate complaints regarding academic matters or the behavior of a faculty member. It is important that students and faculty have a common understanding of how such complaints may be expressed and resolved. Students with complaints regarding academic matters should initially seek resolution from members of the faculty, the graduate studies director of their program, and/ or the chairperson of their department or administrative committee. Complaints which are not resolved at the departmental level may be addressed to the Dean of the Graduate School of Arts and Sciences or the Associate or Assistant Deans. Ph.D. students in Engineering have the additional option of taking complaints to deans in the School of Engineering and Applied Science. All complaints regarding academic integrity issues should be addressed to the Associate Dean of the Graduate School. The Ombudsman, a full-time faculty member in Arts and Sciences, is also available to assist Arts and Sciences graduate students in resolving academic matters.

"Washington University policies state that members of the University community can expect to be free from discrimination, discriminatory harassment, and sexual harassment. Students, faculty, staff, and outside organizations working on campus are urged to actively support these policies. More information is available from the University's web site, www.wustl.edu/policies. The Deans of the Graduate School also serve as liaisons to graduate students.

"A complaint on the grounds of alleged sexual discrimination may be appealed to the Vice Chancellor for Human Resources, who will determine whether to convene the Title IX Grievance Committee to hear the case."

POLICY AND PROCEDURE UPDATES

New Procedure for Dissenting Vote(s)

"Faculty members of the Dissertation Examination Committee normally will examine the student candidate and vote to approve the dissertation. In the vast majority of cases these votes are unanimously for approval. In the rare case that there are faculty concerns that can not be resolved through subsequent revisions, and which therefore result in dissenting (negative) vote(s), the Committee Chair will refer the case to the Graduate Dean for resolution.

"In the case of a single dissenting vote, the Committee Chair and the dissenting voter will be asked to explain the reasons for the dissent in a letter to the Graduate Dean. After consulting with these and other members of the Committee, the Graduate Dean may then decide to accept the majority opinion and approve the Dissertation, or may seek the opinion of an additional reader. After considering this additional evidence, the Graduate Dean may approve, or may decline to approve, the Dissertation.

"In the case of two or more dissenting votes, the Committee Chair and the dissenting voters will again be asked to explain the reasons for the dissent. The Dean may then decide to decline to approve the Dissertation, or to ask the Department or Graduate Program to name a Resolution Committee, consisting of three tenured or tenure-track professors at Washington University or elsewhere who did not serve on the original committee, to re-examine the Dissertation and the candidate. A unanimous positive recommendation from this committee will be required in order for the Dean to approve the Dissertation. Failure of a Department or Graduate Program to identify three faculty members to serve on this Resolution Committee will be tantamount to a rejection of the Dissertation."

Change in Calendar for Completing Advanced Degrees

One sentence in the first paragraph on page 26 of the 2006-2009 *Bulletin* has been revised to read as follows:

"Students in doctoral programs have seven calendar years, dated from the time of their first registration in a graduate degree program at Washington University, to complete degree requirements."

Eligibility for extending time to degree and procedures for requesting such extensions have not changed. Please consult the *Bulletin*.

Dissertation Examination Policy Change

One sentence in the last paragraph on page 30 of the 2006-2009 *Bulletin* has been revised to read as follows:

"The committee before which the student is examined normally consists of at least six faculty members, five of which must be tenured or tenure-track (four faculty members from the student's major department or program together with at least two faculty members from other departments, programs, or schools of the University)."
